Its proposed phasing out would have shut the door on thousands of young Ugandans, many from disadvantaged backgrounds.


Your defence of HEAC is not just about a program—it is a statement of principle: that higher education in Uganda must remain accessible, just, and inclusive.

Legitimizing the Forum's position as one of the key advisors on higher education policy



Strategic Area 2: Supporting a National PhD Development Plan



The Challenge

The PhD deficit in Uganda remains alarmingly high, limiting training, innovation, research capacity and academic excellence.

Our Proposal

UVCF continues to advocate for a Doctoral Training and Research Fund that would:

- Include private chartered universities
- Address critical staff development needs
- Close research capacity gaps
- Strengthen Uganda's knowledge economy



Strategic Areas 3 & 4: Strengthening Capacity

Strengthening the UVCF Secretariat

With minimal staff and resources, the Secretariat continues to punch above its weight. We need investment in:

- Personnel capacity
- Transport infrastructure
- Digital systems and platforms

We will continue appealing to government and partners for direct logistical support.

Leveraging Emerging Technologies

Universities must be at the center of Uganda's innovation ecosystem through:

- Private sector partnerships
- Research commercialization
- Entrepreneurship programs
- Industry apprenticeships

We need a legal policy framework with tax incentives for university-industry collaboration.

Countries like South Africa, Egypt, and recently Ghana provide tax rebates to industries that collaborate with universities.



Looking Forward: Government Engagement

We must continue to engage with government at multiple levels. In the coming months, we seek to meet:

1 Minister of State for Higher Education

To follow up on our policy submissions and discuss implementation strategies

2 Permanent Secretary, Ministry of Education and Sports

To develop concrete implementation pathways for our recommendations

First Lady and Minister for Education and Sports

To discuss sustainable, long-term support for the higher education sector
